

# Relationships and Sex Education Policy

#### 1. Aims

#### The aims of relationships and sex education (RSE) at our school are to:

- > At 'Oak Lodge' we believe that Relationships and Sex Education forms an integral part of our Personal, Social, Health Education (PSHE) and Citizenship curriculum, and it is linked to the National Curriculum for Science. Through the RSE curriculum we aim to
- > Provide a carefully planned curriculum that covers human development, relationships, sexuality and family life, in line with statutory requirements and in an appropriate way taking into account the pupils' age and stage of development
- > Prepare pupils for puberty, and give them an understanding of sexual development and the importance of health and hygiene
- > Help pupils develop feelings of self-respect, confidence and empathy
- > Create a positive culture around issues of sexuality and relationships
- > Teach pupils the correct vocabulary to describe themselves and their bodies
- > Respect and tolerance towards others who may have different backgrounds, cultures, feelings, views and sexuality.
- > Provide a positive framework within which discussions on these issues can take place

### This is based on the following principles:

- > The right of people to hold their views within the boundaries of respect for the rights of others.
- > The acceptance of the responsibility for and the consequences of personal actions.
- > The right not to be abused by or taken advantage of by other people.
- > The right to accurate information about relationships.
- > An awareness of the way another person feels.
- > The value of stable loving relationship.
- > Mutual support and co-operation.
- > Honesty and openness.

### 2. Statutory requirements

As a maintained secondary school we must provide RSE to all pupils as per the <u>Children and Social work act</u> 2017.

In teaching RSE, we must have regard to to <u>guidance</u> issued by the secretary of state as outlined in section 403 of the <u>Education Act 1996</u>.

Schools have long been expected to provide education that prepares children to take their place in the adult world, learning about how their bodies work, how to be healthy and stay safe both in the real world and online, and how to get on with others in a positive and friendly way. Since the equalities Act of 2010 schools have also been required to ensure that the education they provide incorporates and promotes the inclusion of all aspects of society, with reference to specific protected characteristics such as race, religion/belief, age, sex/gender, gender reassignment, marital/partnership status, sexuality and ability, and that this education should be impartial.

### 3. Policy development

This policy has been developed in consultation with staff, pupils and parents. The consultation and policy development process involved the following steps:

- 1. Review by the Senior Team inconjunction with a working group pulled together all relevant information including relevant national and local guidance (Wandsworth is a member of the PSHE association and provides access for Oak Lodge School to follow their guidance) as well as relevant information for SEN pupils.
- 2. Consultations with school staff and external stakeholders and parents, who were given the opportunity to look at the policy and make recommendations
- 3. Parents also have the opportunity to discuss RSE at annual reviews for their individual child. This feedback is taken into account at our bi-annual review.
- 4. Pupil consultation we investigated what exactly pupils want from their RSE through our school and wellbeing leaders.
- 5. Ratification once amendments were made, the policy was shared with governors and ratified

#### 4. Definition

RSE is about the emotional, social and cultural development of pupils, and involves learning about relationships, sexual health, sexuality, healthy lifestyles, diversity and personal identity.

RSE involves a combination of sharing information, and exploring issues and values.

RSE is not about the promotion of sexual activity.

### 5. Curriculum

Our curriculum is set out as per curriculum overview (see website / internal POLICIES documents) but we may need to adapt it as and when necessary.

We have developed the curriculum in consultation with parents, pupils and staff, taking into account the age, needs and feelings of pupils. If pupils ask questions outside the scope of this policy, teachers will respond in an appropriate manner so they are fully informed and don't seek answers online.

RSE focuses on giving young people the information they need to help them develop healthy, nurturing relationships of all kinds including:

- > Families
- > Respectful relationships, including friendships
- > Online and media
- > Being safe
- > Intimate and sexual relationships, including sexual health

These areas of learning are taught within the context of family life taking care to ensure that there is no stigmatisation of children based on their home circumstances (families can include single parent families, LGBT parents, families headed by grandparents, adoptive parents, foster parents/carers amongst other structures) along with reflecting sensitively that some children may have a different structure of support around them (for example: looked after children or young carers).

### 6. Delivery of RSE

RSE is delivered as part of the PSHE curriculum. At times RSE is delivered through topics in other subject areas to complement the pupils understanding of themes. PSHE is taught through a PSHE lead for the vocational pathway pupils form year 9 and above and by class teachers for the skills pathway. Our pupils due to their delayed language, cogitative ability and D/deaf / SCLN needs – the curriculum delivery has to be adapted.

We have external specialists – Sign Health – who deliver particular topics to our older pupils. Pupils are taught in class groups which are mixed – however at times we have gender based lessons. Science lessons complement elements of the RSE curriculum.

### 7. Roles and responsibilities

### 7.1 The governing board

The governing board will approve the RSE policy, and hold the headteacher to account for its implementation.

#### 7.2 The headteacher

The headteacher is responsible for ensuring that RSE is taught consistently across the school, and for managing requests to withdraw pupils from non-statutory components of RSE (see section 8).

#### 7.3 Staff

Staff are responsible for:

- > Delivering RSE in a sensitive way
- > Modelling positive attitudes to RSE
- > Monitoring progress
- > Responding to the needs of individual pupils
- Responding appropriately to pupils whose parents wish them to be withdrawn from the non-statutory components of RSE

Staff do not have the right to opt out of teaching RSE. Staff who have concerns about teaching RSE are encouraged to discuss this with the headteacher.

### 7.4 Pupils

Pupils are expected to engage fully in RSE and, when discussing issues related to RSE, treat others with respect and sensitivity.

#### 7.5 Parents

Parents / Carers - to support the school in delivering the curriculum and to engage in any consultation process.

### 8. Parents' right to withdraw

Parents have the right to withdraw their children from the non-statutory / non-science components of Sex Education within RSE up to and until 3 terms before the child turns 16. After this point, if the child wishes to receive sex education rather than being withdrawn, this become the choice of the young person.

Requests for withdrawal should be put in writing using the form found in Appendix 2 of this policy and addressed to the headteacher.

A copy of withdrawal requests will be placed in the pupil's educational record. The headteacher will discuss the request with parents and take appropriate action.

Alternative work will be given to pupils who are withdrawn from sex education.

### 9. Training

Staff are trained on the delivery of RSE as part of their induction and it is included in our continuing professional development calendar.

The headteacher will also invite visitors from outside the school, such as school nurses or sexual health professionals, to provide support and training to staff teaching RSE.

### 10. Monitoring arrangements

The delivery of RSE is monitored by Deputy Headteacher Curriculum and Deputy Pastoral. This is achieved through planned scrutinies, learning walks and performance management review meetings.

Information will be reviewed in conjunction with safeguarding concerns and pastoral feedback as to pupils wellbeing.

Pupils' development in RSE is monitored by class teachers as part of our internal assessment systems.

This policy will be reviewed by The Deputy Headteachers & Headteacher on a biennial basis. At every review, the policy will be approved by the governing board.

Appendix 1: By the end of secondary school pupils should know

	Why marriage is an important relationship choice for many couples and why it must be freely entered into
	The characteristics and legal status of other types of long-term relationships
	The roles and responsibilities of parents with respect to raising of children, including the characteristics of successful parenting
	• How to: determine whether other children, adults or sources of information are trustworthy: judge when a family, friend, intimate or other relationship is unsafe (and to recognise this in others' relationships); and, how to seek help or advice, including reporting concerns about others, if needed
Respectful relationships, including friendships	The characteristics of positive and healthy friendships (in all contexts, including online) including: trust, respect, honesty, kindness, generosity, boundaries, privacy, consent and the management of conflict, reconciliation and ending relationships. This includes different (non-sexual) types of relationship
	Practical steps they can take in a range of different contexts to improve or support respectful relationships
	How stereotypes, in particular stereotypes based on sex, gender, race, religion, sexual orientation or disability, can cause damage (e.g. how they might normalise non-consensual behaviour or encourage prejudice)
	• That in school and in wider society they can expect to be treated with respect by others, and that in turn they should show due respect to others, including people in positions of authority and due tolerance of other people's beliefs

Online and media	Their rights, responsibilities and opportunities online, including that the same expectations of behaviour apply in all contexts, including online
	About online risks, including that any material someone provides to another has the potential to be shared online and the difficulty of removing potentially compromising material placed online
	Not to provide material to others that they would not want shared further and not to share personal material which is sent to them
	What to do and where to get support to report material or manage issues online
	The impact of viewing harmful content
	• That specifically sexually explicit material e.g. pornography presents a distorted picture of sexual behaviours, can damage the way people see themselves in relation to others and negatively affect how they behave towards sexual partners
	That sharing and viewing indecent images of children (including those created by children) is a criminal offence which carries severe penalties including jail
	How information and data is generated, collected, shared and used online
